STATEMENT OF FAITH

- 1. We believe the Bible to be the only, inspired, infallible, authoritative, inerrant Word of God. (2 Timothy 3:15; 2 Peter 1:21)
- 2. We believe there is only one God, eternally existent in three persons Father, Son and Holy Spirit. (Genesis 1:1; Matthew 28:19, John 10:30)
- 3. We believe in the deity of Christ (John 10:33), His virgin birth (Isaiah 7:14; Matthew 1:23; Luke 1:35); His sinless life (Hebrews 4:15; 7:26); His miracles (John 2:11); His vicarious and atoning death (I Corinthians 15:3; Ephesians 1:7; Hebrews 2:9); His resurrection (John 11:25; I Corinthians 15:4); His ascension to the right hand of the Father (Mark 16:19); His personal return in power and glory (Acts 1:11; Revelation 19:11).
- 4. We believe in the absolute necessity of regeneration by the Holy Spirit for salvation because of the exceeding sinfulness of human nature, and that men are justified on the single ground of faith in the shed blood of Christ and that only by God's grace and through faith alone we are saved. It is not something we earn or deserve. It is offered in grace and received by faith in Jesus Christ alone. (John 3:16, 5:24; Romans 3:23, 5:8-9; Ephesians 2:8-10; Titus 3:5).
 - 5. We believe the biblical definition of marriage as the covenant relationship between one naturally-born man and one naturally-born woman. (*Genesis 2:23-24*)

STATEMENT ON GENDER AND SEXUALITY

- 1. We believe that all people must be afforded compassion, love, kindness, respect, and dignity. It will always be our intent as a school to reflect these qualities. Any behavior or attitudes not displaying these qualities should be repudiated, as they are not in accord with scripture or the Spirit of Christ. (*John 13:35*)
- 2. We believe that God wonderfully and immutably created each person as distinctly male or female (*Gen. 1:26-31, 2:18-25, 5:1, 2*). These two distinct and divinely representative genders together reflect the image and nature of God. We believe that the fullest, most rewarding experience of life includes the acceptance of a person's God-given biological gender. The rejection of one's biological gender diminishes the reflection of the image of God within a person.
- 3. We believe that God intends sexual intimacy to occur only between a man and a woman who are married to each other. Any form of sexual intimacy outside of such marriage is hurtful to God's heart and harmful to the spiritual health of those involved (1 Cor. 6:15-7:6, Eph. 5:3-7). Such activities include, but are not limited to adultery, fornication, homosexual conduct, and pornography.
- 4. We believe that God offers redemption, transformation, and restoration to all who see Him through Jesus Christ (1 Cor. 6:11).

NON-DENOMINATIONAL POSITION

These statements are based on essential Christian beliefs that we strongly support as the primary doctrine for teaching. Lighthouse Preparatory Academy does not promote or endorse any particular denomination. It is our desire to maintain this position for the purpose of unity and fairness to each student. Other doctrinal issues upon which this ministry has no official stance will be considered secondary doctrine and will not be taught. In the event secondary doctrine is brought up, students will be referred to the family and church for final authority. We desire to remain united in the salvation and love of Christ, avoiding any dissension that may be caused by denominational distinctiveness.
